- My answers


My Results

After completing a self-assessment, your scores will be displayed visually on the 'My results' tab screen. The scores in the first chart show the percentage progress to achieving each of the <u>three pillars of Employer Standards</u>:



The second chart shows your percentage progress to achieving each of the nine individual Standards. The bars are colourcoded as follows:

- Red: Aspiring (0-49%)
- Green Achieving (50-89%)
- Blue Exceeding (90-100%):

This chart enables you to compare your self assessment scores against the average scores of all employers with your sector.


Regional average
